The charity's purposes are to advance the education of the public in the knowledge, understanding and appreciation of the art of cinema, film, video and other forms of moving image, in particular (but not limited to) those made by filmmakers in the Hull and Humber region for the public benefit. In setting objectives and planning activities for the year, the Trustees considered how the charity's activities would further these purposes and benefit its beneficiaries. The Trustees have reviewed the charity's activities during the year and believe that these activities have provided clear public benefit. In particular, the charity has sought to ensure that its services are accessible to those

		who are eligible to benefit, and that any restrictions on access are reasonable and justified in line with the charity's aims, primarily by keeping ticket prices for festival events low while still being sufficient to cover costs associated with the events. The Trustees regularly review the charity's activities and outcomes to ensure they continue to meet the charity's objectives and deliver public benefit in accordance with Charity Commission guidance.

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	The period covered by this report included the 2nd edition of Unthinkable Film Festival, and the first since the establishment of UNTHINKABLE FILM FESTIVAL HULL CIO as a registered charity. Unthinkable Film Festival 2024 ran from 3 to 6 October and featured a total of 17 events and the screening of a total of 42 films. The majority of these films were produced by filmmakers in the Hull area and wider Yorkshire region, giving an outlet and an audience to local filmmakers who otherwise would not have the opportunity to see their work on screen. A total of 45 local filmmakers also attended a film production workshop and a one-to-one mentoring session with established figures in the local and national creative sector, giving the more opportunities to gain new skills, contacts and ideas to develop their own careers and practice. Film screenings were attended by a total of over 400 ticket holders, with the dedicated screening of locally made short film showing to a completely sold out audience and the final award screening drawing an 80% capacity crowd, establishing the demand for innovative, boundary-pushing short film from exciting filmmakers, and giving local audiences the chance to see film of this nature on a big screen that would not otherwise exist in the city.

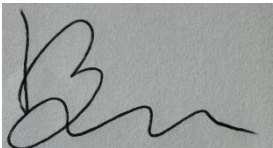
