The club has a youth Welfare Officer as well as an Adults Welfare Officer which oversees all safeguarding requirements and discipline.

The organisational structure is Trustee's who work closely with the Executive Committee of the football club. The committee consists of Chair, Vice Chair, Secretary (U7-U12) and Secretary (U13 to adult football) Treasurer and Welfare Officers. Our coaches are all involved in the decision making process at the club and everything that is organised or planned is subject to approval from all those members

Our major risks are around children's welfare and safeguarding. The club ensures this is the centre piece of all our activities. We have a clear safeguarding procedure in relation to reporting and reacting. We follow the FA guidelines closely

The main achievements of the Charity during the period are being able to provide access with no barriers to football coaching and activities to 310 children and adults every week.

Ensuring that every family no matter their financial resources gets equal access to football activities, kit, facilities and equipment.

In some cases we have waived subscriptions or lowered them in order to ensure the continuance of football for the child.

Hosting an annual football tournament that saw over 1000 players attend over two days in June 2024.

Working with our community partner groups in particular "Friends of Hollingworth" to support events such as Festival on the Green and purchasing the lights/decorations for the Community Christmas Tree. Donating Chocolate eggs for annual Easter Egg hunt for the Hollingworth Community.

Supporting the local foodbank by arranging club donation nights (Trussell Trust)

Ensuring our children have access to the correct medical equipment in order to continue playing football – Charity has purchased several pairs of sports goggles and equipment in relation to hearing impairment.

Starting the clubs first ever all girls football team and ensuring they are fully supported and developed.
