TO RELIEVE THE NEEDS OF ADULTS WITH A PHYSICAL DISABILITY, LEARNING DIFFICULTY, NEURODIVERSITY OR A SENSORY IMPAIRMENT PRIMARILY THROUGH:- PROVIDING A RANGE OF SUPPORT, ADVICE, TRAINING OPPORTUNITIES TO DEVELOP ABILITIES, LEARN AND DEVELOP NEW SKILLS INCLUDING LIFE AND EMPLOYMENT SKILLS TO ENABLE PEOPLE TO LIVE INDEPENDENTLY;- PROVIDING RECREATIONAL AND LEISURE TIME ACTIVITIES PROVIDED IN THE INTEREST OF SOCIAL WELFARE DESIGNED TO IMPROVE THEIR CONDITIONS OF LIFE;- SUCH OTHER WAYS AS THE TRUSTEES MAY DETERMINE.
