Objects: THE OBJECTS OF THE CHARITY ARE:1. FOR THE PUBLIC BENEFIT TO PROMOTE THE EDUCATION (INCLUDING SOCIAL AND PHYSICAL TRAINING) OF THE BENEFICIARIES IN THE AREA OF BENEFIT IN SUCH WAYS AS THE TRUSTEES THINK FIT, INCLUDING BY:A) AWARDED SCHOLARSHIPS, EXHIBITIONS, BURSARIES, MAINTENANCE ALLOWANCES OR GRANTS TENABLE AT ANY EDUCATIONAL INSTITUTION TO BENEFICIARIES; ORB) MAKING GRANTS TO ANY EDUCATIONAL INSTITUTION ATTENDED BY BENEFICIARIES; ORC) PROVIDING FINANCIAL ASSISTANCE, OUTFITS, CLOTHING, EQUIPMENT, INSTRUMENTS OR BOOKS TO ASSIST BENEFICIARIES TO PURSUE THEIR EDUCATION (INCLUDING THE STUDY OF MUSIC AND OTHER ARTS), TO UNDERTAKE TRAVEL IN FURTHERANCE THEREOF, OR TO PREPARE FOR OR ENTER A PROFESSION, TRADE, OCCUPATION OR SERVICE ON LEAVING AN EDUCATIONAL INSTITUTION.
