DEBATING AND PROPOSING POLICIES AND OTHER MATTERS AFFECTING MAJOR PARISH CHURCHES, INCLUDING THEIR ROLE IN ADVANCING EDUCATION, COMMUNITY DEVELOPMENT, ARTS, CULTURE AND HERITAGE; AND ENVIRONMENTAL PROTECTION AND IMPROVEMENT.
