TO ADVANCE THE EDUCATION OF THE PUBLIC IN THE PRINCIPLES OF BUDDHISM AND PROMOTE THE STUDY AND APPLICATION OF THOSE PRINCIPLES. IN FURTHERANCE OF THESE OBJECTS BUT NOT OTHERWISE, THE TRUSTEES SHALL HAVE POWER: TO ESTABLISH A RETREAT CENTRE AND TO MAINTAIN AND MANAGE SUCH A CENTRE FOR ACTIVITIES PROMOTED BY THE CHARITY IN FURTHERANCE OF THE ABOVE OBJECTS.

We offer training on these practices and Buddhism, and are working towards establishing a retreat centre to further these activities.
