Objects: THE OBJECTS OF THE CHARITY ('THE OBJECTS') ARE: TO ADVANCE SUCH CHARITABLE PURPOSES FOR THE PUBLIC BENEFIT (ACCORDING TO THE LAWS OF ENGLAND AND WALES) AS THE TRUSTEES SEE FIT FROM TIME TO TIME IN PARTICULAR BUT NOT LIMITED TO PROMOTING EDUCATION OF YOUNG PEOPLE, RELIEF OF POVERTY, ADVANCING ISLAMIC RELIGIOUS EDUCATION AND PROVISION OF HEALTHCARE. THE CHARITY WILL FOR THE PUBLIC BENEFIT ADVANCE GENERAL AND SPECIALIST HEALTHCARE IN AREAS OF NEED ACROSS THE GLOBE BY BUT NOT LIMITED TO:- FUNDING AND SUPPORTING MEDICAL OUTREACH PROJECTS TO PROVIDE SPECIALIST SURGICAL/MEDICAL TREATMENT TO PATIENTS IN AREAS REQUIRING THIS EXPERTISE.- TRAINING OF MEDICAL PERSONNEL. - PROVIDING GRANTS USED TO DIRECTLY FUND HEALTHCARE DELIVERY, SERVICES AND THE DEVELOPMENT OF HEALTHCARE FACILITIES AND PREMISES. THE CHARITY WILL FOR THE PUBLIC BENEFIT PROMOTE RELIGIOUS ISLAMIC EDUCATION AND WORSHIP IN IDENTIFIED AREAS OF NEED ACROSS THE WORLD BY BUT NOT LIMITED TO:- SUPPORTING THE BUILDING, DEVELOPMENT AND RUNNING OF ISLAMIC SCHOOLS AND PLACES OF WORSHIP (MOSQUES) WHICH PROVIDE EDUCATION IN ACCORDANCE WITH THE PRINCIPLES AND PRACTICES OF THE ISLAMIC FAITH.- PROMOTING THE STUDY OF RELIGIOUS TEACHINGS, PRACTICES AND SCRIPTURES (QURAN) OF THE ISLAMIC FAITH. THE CHARITY WILL FOR THE PUBLIC BENEFIT ADVANCE EDUCATION OF YOUNG PEOPLE IN AREAS OF NEED ACROSS THE WORLD BY BUT NOT LIMITED TO: - SUPPORTING SCHOOLS, INCLUDING BUILDING, DEVELOPING, AND MAINTAINING SCHOOLS.- SUPPORTING TEACHER TRAINING FOR SUCH SCHOOLS- PROVIDING GRANTS TO STUDENTS IN FULL-TIME EDUCATION TO FUND FOR BUT NOT LIMITED TO BOOKS, COMPUTERS, SCHOOL UNIFORM AND EDUCATION FEES. FOR THE PUBLIC BENEFIT, THE CHARITY WILL RELIEVE POVERTY ANYWHERE IN THE WORLD BY BUT NOT LIMITED TO:- THE PROVISION OF GRANTS TO INDIVIDUALS IN NEED OR OTHER CHARITIES FOR THE PURCHASE OF ESSENTIAL ITEMS FOR DAILY LIVING.- PROVIDING GRANTS FOR VOCATIONAL TRAINING, NECESSARY TOOLS AND EQUIPMENT TO SUPPORT INDIVIDUALS TO GENERATE A SUSTAINABLE INCOME AND BE SELF-SUFFICIENT- FUNDING GRANTS FOR PROVISION OF SAFE WATER AND SANITATION IN AREAS OF NEED.
