Activities: Egan Road Church seeks to be a neighbourhood centre with a vision to make people "Known, Loved and a part of Community". We offer weekly groups for a range of people including: Tots stay-and-play for 0-5s and their carers, Youth Club weekly session for 11-18, Worship Service Sundays, Community Meals every other Sunday. Other coffee mornings, community meals and events vary regularly.
