2. Structure, governance, and management.

2.1 The structure of the charity.

2.2 The management of the charity.

On 31 March 2024 there were five charity trustees who comprise the Management Committee of the association.

2.3 The Recruitment and training of charity trustees.

On election, each new member signs an eligibility declaration Clause 6 and confirm they understand the duties and responsibilities involved in being a trustee. The duties and responsibilities of managing charity trustees are reviewed at meetings of the Management Committee when necessary.

3. Aims, Objectives.

- 3.1 The aim of the charity is to promote community development and provide a safe and pleasant environment for activities to improve the quality of life of the inhabitants of the area of benefit.
- 3.2 The charitable objects of the charity are "for the purposes of physical and mental training and recreation and social, moral, and intellectual development through the medium of lectures, classes, clubs, recreations, and entertainments or otherwise as may be found expedient for the inhabitants of Romaldkirk and district without distinction of political, religious, or other opinions.

4. Achievements and Performance.

4.1 Achievements and Performance (April to March 2025)

The trustees are progressing the transfer of assets of the Romaldkirk Reading and Recreation trust (523403) to the new CIO The Romaldkirk Reading and Recreation Room trust (1208140). This has been hampered by banking delays, solicitor complications and delays regarding transfer of the building via Land Registry. Once completed all assets will be transferred and trust (523403) progressed to closure.
