Our Youth section has also begun to grow with the same process of the Nippers feeding the group for it to expand. Our adult volunteer numbers have grown with the majority holding recognised SLSGB qualifications in coaching and/or water safety or are in the process of obtaining the qualification. We have increased our presence at regional and national competitions. We have begun to work with SLSGB to be able to deliver Splash School programmes to local school children who would otherwise not have access to or be involved in surf lifesaving activities.
