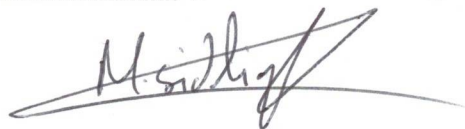

1. Accounting Policies

1.1 Basis of accounting

The financial Statements have been prepared under the historical cost convention. The Financial statements have been prepared in accordance with the Statement of Recommended Practice, Accounting and Reporting by Charities (SORP 2005), applicable accounting standards and Companies Act 2006

1.2 Incoming Resources
