TO PROMOTE THE CONSERVATION, PROTECTION AND IMPROVEMENT OF THE PHYSICAL AND NATURAL ENVIRONMENT OF A GREEN AREA KNOWN AS THE ECO PARK FOR THE BENEFIT OF THE LOCAL COMMUNITY OF CEFN FFOREST AND VISITORS, PRIMARILY BUT NOT EXCLUSIVELY BY THE MAINTENANCE AND IMPROVEMENT OF THE GREEN AREA.
