Financial Review (Narrative)

The charity's income during the reporting period was primarily derived from public donations, with a significant proportion received during the month of Ramadan. These funds enabled the charity to deliver essential aid to vulnerable communities in Yemen.

Expenditure during the period was focused on delivering the charity's objectives, including food aid, cash assistance, medical support, and the completion of a water well project providing sustainable access to clean water.

The charity does not hold significant reserves, as funds are typically distributed as received in order to respond to urgent humanitarian needs. The trustees consider this approach appropriate given the nature of the charity's work.
