This report covers the period to 30 th June 2025 and includes the first three quarterly meeting of the trustees. From the outset the trustees found themselves awarding to applications from small charities and groups where it was seen that the money would go directly to those who needed it. In the period we awarded 25 grants which totalled £28582.

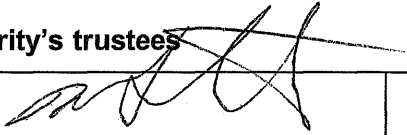
