The financial statements have been prepared in accordance with the Accounting Policy set out in the Charity's trust deed and comply with the Charities Act 1993 and Statement of Recommended Practice: Accounting and Reporting by Charities published in 2005.

Objectives and Activities of the Charity for Public Benefit

The Purpose of the charity as set out in its governing document are ff:

- 1 To propagate the gospel of Jesus Christ and advance the Christian faith in accordance with the statement of beliefs
- 2 To bring humanitarian relief to the lowly and vulnerable, promoting their wellbeing.
- 3 To equip and empower people in the knowledge of truth of the gospel characterised by love, thereby bringing liberation, confidence and peace to the many.
- 4 To look after orphans and widows and the less privileged

The main activities undertaken by the charity in relation to those purposes during the year

- The charity collaborated with The Covenant Nation UK church to organise two events namely, Instant Food bank and Christmas on the Street Outreach events. These outreach events brought humanitarian relief to the most vulnerable in the Catford community and the surrounding area.
- We offered prayers and counselling and emotional support during our outreach events which saw many responses and impacts.
- We also undertook personal and group evangelisms
- We distributed free bibles and Christian literatures to help community with their faith journey.
- We held motivational talks to help young people make better life choices.
- We gave out free hot meals, foodstuffs and household products.

Statement of Trustees' Responsibilities

They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.
