Trustees' Report

The Charity will hold fundraising events in order to make grants and donations in its efforts to achieve its objectives. However, no activities or events were held during the period under review; in this regard the following circumstances should be noted.

At an Extraordinary Meeting of the Trustees of The Sidmouth Lions Club Charity Trust Fund Registered Charity No. 1015311 ('the Trust') held on 21 May 2024, that charity's Trustees approved the intention for its activities and assets to be transferred to Sidmouth Lions Club (CIO) following its incorporation and entry on the Charity Commission register. On 22 October 2024 the Charity Commission for England and Wales issued an authorisation for the transfer of the Trust's assets & liabilities to the new CIO in accordance with section 105 of the Charities Act 2011.

At a meeting of the Trust's Trustees on 12 March 2025 an amendment to its Trust Deed was approved confirming its ability to transfer its assets and activities to Sidmouth Lions Club (CIO) with effect from 1st July 2025.

Accordingly, the Charity, Sidmouth Lions Club (CIO), commenced fund raising and grant making activities with effect from 1st July, 2025 i.e. immediately following the year under review.
