Objectives and Activities

Mercy Oceans was registered during the period. The charity's objectives are to operate for charitable benefit in accordance with its governing document. Activities during the period focused on establishing the charity, fundraising, and hosting community gatherings where food was provided to adults.

Public Benefit

The trustees confirm that they have complied with the duty in section 4 of the Charities Act 2011 to have due regard to public benefit guidance when exercising their powers and duties.

Financial Review

During the period, the charity received income of £25,246, primarily from donations. A small amount (£56) was generated from in-house shop sales. Expenditure totalled £19,667, resulting in a surplus of £5,579, which will be retained to support future charitable activities.

Structure, Governance and Management

Mercy Oceans is a Charitable Incorporated Organisation (CIO – Foundation) governed by its trustees, who are responsible for the strategic direction and oversight of the charity. Trustees meet as required and act in accordance with the charity's constitution and Charity Commission guidance.

The trustees regularly review the risks facing the charity and have established policies and procedures to manage financial, operational, and safeguarding risks.

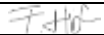
