Structure, Governance and Management

Memon Association UK is a Charitable Incorporated Organisation (CIO), registered with the Charity Commission on 25 June 2024. The CIO is governed by its constitution. The trustees are responsible for the overall management and administration of the charity and for ensuring that it is operated in accordance with its governing document and applicable charity law.

Trustees are appointed in accordance with the provisions of the CIO's constitution. New trustees are expected to be made aware of their duties and responsibilities as charity trustees.

Objectives and Activities

The charitable purposes of Memon Association UK are those set out in its constitution. During the reporting period the CIO remained dormant and did not undertake charitable activities.

In considering the charity's future activities, the trustees have regard to the Charity Commission's guidance on public benefit where relevant.

Achievements and Performance

No charitable activities were undertaken during the period from registration on 25 June 2024 to 31 December 2024. Accordingly, there were no activities or achievements to report for the period.

Financial Review

On the basis of the information provided to prepare this report, the CIO received no income and incurred no expenditure during the reporting period. No assets or liabilities were transferred from the former unincorporated charity to the CIO during the period, and the CIO held no assets or liabilities at 31 December 2024. The CIO therefore remained dormant throughout the reporting period.

Reserves Policy

As the CIO had no funds or assets at 31 December 2024, it held no reserves. The trustees will review and adopt an appropriate reserves policy when the CIO commences activities and receives funds.

Funds Held as Custodian Trustee

The CIO did not hold any funds as custodian trustee during the reporting period.

Plans for Future Periods

The trustees intend to make the necessary arrangements for the CIO's future operation, including any appropriate transfer of activities and assets from the former unincorporated charity, before commencing charitable activities through the CIO.

Trustees' Responsibilities
