Activities: PERFORMING ARTS, TRAINING WORKSHOPS, PRODUCTIONS, EDUCATIONAL WORKSHOPS TO HELP NEURODIVERGENT AND LEARNING DISABLED PEOPLE DEVELOP AND GAIN NEW SKILLS AND TO RAISE PUBLIC AWARENESS OF THE ISSUES AFFECTING SUCH PEOPLE, BOTH GENERALLY AND IN RELATION TO THEIR SOCIAL EXCLUSION.
