2. Its structure and details of how it is managed, including how it recruits trustees

Nuu Theatre Productions is a Charitable Incorporated Organisation governed by its constitution adopted on registration. Under the constitution, the charity must have a minimum of three trustees, who are responsible for the strategic leadership and overall governance of the organisation.

No new trustees were appointed and 1 resignation took place during the reporting period. The trustees met informally throughout the year to oversee future planning and ensure ongoing compliance with the Charities Act 2011.

As a small CIO, NuU Theatre Productions has no employees and no subcommittees. All activities were undertaken by the trustees on a voluntary basis.

3. Its activities and objectives in the year

In line with clause 3 of the constitution, NuU Theatre Productions' purpose is:

To advance in life and help young people aged 18 to 30 through the provision of support to assist them in developing their skills, capacities and capabilities, enabling them to pursue a career in the performing arts and participate in society as mature and responsible individuals

Public Benefit

The trustees confirm that they have complied with their duty under section 17 of the Charities Act 2011 to have due regard to the Charity Commission's guidance on public benefit. While no programme activity took place during this reporting year, all planning work undertaken was directed toward delivering the charity's public benefit purpose in future years.

4. Its achievements and performance, including reporting on its public benefit

During this period, the charity entered a planned hiatus. Although no public-facing programmes were delivered, the year focused on strengthening the foundation required for future delivery. Key developments included:

4.1 Strategic Pause

The trustees formally agreed a pause in operational activity in order to review sustainability, refine the charity's vision, and prepare for strategic organisational growth.

4.2 Consolidation of Values

Work was undertaken to articulate and update the core values that will guide all future activity. This included review against the charity's objects, current sector needs, and the experiences of young people entering the performing arts industry.

4.3 Planning for Leadership and Staffing

The trustees began the process of designing a refreshed organisational structure. This included:

- setting out the role scopes for a future executive team
- identifying skills, capacities and leadership qualities required in alignment with the constitution and charitable objects

- establishing a pathway for recruitment in 2025–2026

This internal strategic work prepares the charity to relaunch its programmes with appropriate governance and leadership in place.

4.4 Governance Compliance

Despite no operational activity, trustees ensured:

- constitutional duties were met
- all statutory registers were maintained
- accounts and records were kept up to date
- filings remained compliant with Charity Commission requirements
