- Providing a safe and welcoming space for members of the public.

The trustees confirm that they have complied with their duty under Section 17 of the Charities Act 2011 to have due regard to the guidance published by the Charity Commission for England and Wales on public benefit.

## Activities, Achievements and Performance

During the reporting period, RCC continued to provide regular religious and community services for residents & wider public despite operational and financial challenges associated with venue arrangements and ongoing organisational development.

The charity successfully maintained:

- Daily prayer services
- Weekly Jummah (Friday) congregational prayers
- Ramadan evening programmes and community prayers
- Eid prayer gatherings
- Educational and spiritual activities for adults and young people.

A significant focus during the year was the continued development and use of community facilities to accommodate growing attendance and provide a safe, accessible, and welcoming environment for worshippers and visitors.

The trustees are pleased to report continued community engagement and strong volunteer support throughout the year. The charity remains committed to strengthening community cohesion, supporting families and young people, and promoting positive engagement within the local area.

The trustees also worked closely with local stakeholders and venue providers to ensure compliance with health and safety, safeguarding, and operational requirements.
