Out of the Can LGBTQ+ Youth Group exists to advance the lives of LGBTQ+ young people aged 12–19 by providing safe, inclusive, and supportive spaces where they can develop confidence, resilience, and a sense of belonging. During the reporting period, the charity delivered 68 youth sessions, alongside a wide range of creative, educational, social, and wellbeing activities. These sessions provided young people with opportunities to build friendships, access trusted adults, develop new skills, and participate in positive community experiences. The charity also worked with external organisations—including mental health, policing, sexual health, and public health services—to ensure young people could access early intervention, information, and support. The benefits of the charity's work are evident in the strong and consistent attendance across both youth groups, the high level of engagement in activities, and the positive relationships formed with volunteers, partner organisations, and the wider community. All services are provided free of charge and are open to any LGBTQ+ young person within the age range, ensuring that the public benefit is accessible and not unreasonably restricted. Through its activities, Out of the Can LGBTQ+ Youth Group promotes wellbeing, reduces social isolation, supports personal development, and contributes to a more inclusive and understanding community. The Trustees are satisfied that the charity's aims and activities clearly demonstrate public benefit.

Activities and Achievements (2024 TAR Period)

Overview of Activities

During the 2024 reporting period, Out of the Can LGBTQ+ Youth Group (OOTC) delivered a vibrant, diverse, and high-impact programme of support, activities, and community engagement for LGBTQ+ young people aged 12–19 across Swindon and Wiltshire. Our work continued to focus on providing safe, inclusive, and empowering spaces where young people can connect, learn, express themselves, and develop confidence and resilience.

Across the year, OOTC delivered 68 youth sessions, maintained strong attendance, expanded partnerships, and strengthened our volunteer base. The Trustees are pleased to report a period of stability, growth, and meaningful impact.

Youth Group Sessions

OOTC delivered:

- 34 sessions for the Young Group (YG)
- 34 sessions for the Older Group (OG)
- 68 sessions in total

Attendance

Engagement remained consistently strong:

- Average attendance:
 - YG: 10 young people per session
 - OG: 22 young people per session
- Combined average: 32 young people per session
- Highest recorded attendance: 44 (Older Group)

These figures reflect the ongoing need for safe LGBTQ+ youth spaces in the region and the trust young people place in OOTC.

Events and Community Engagement

OOTC maintained a visible and active presence across Swindon and Wiltshire, strengthening community connections and raising awareness of LGBTQ+ youth needs. Key events attended included:

- Swindon & Wiltshire Pride (August 2024)
- Freshers Fairs at Swindon College and New College (October 2024)
- Enchanted Light Gardens Trail (December 2024)

During this period, OOTC:

- Recruited one new volunteer (February 2025)
- Retained all existing volunteers, demonstrating strong organisational culture and support

Programme of Activities

A rich and varied programme was delivered across both youth groups, including:

Creative, Social & Skills-Building Activities

- *No Added Sugar* sessions preparing young people for volunteering at Swindon & Wiltshire Pride
- STEM programme (6 sessions) delivered by an LGBTQ+ STEM Ambassador, funded by Pride in STEM
- Creation of a community light installation for the Enchanted Light Garden Trail
- Nature walk and sustainable plant pot making
- Regular craft sessions, games, and social activities including Uno
- Queer Prom, organised by the Older Group
- Halloween and Christmas celebrations
- LGBT History Month activities

Educational & Supportive Workshops

OOTC welcomed a range of external organisations to deliver information, guidance, and wellbeing support:

- Papyrus (suicide prevention)
- Wiltshire Police PCSO
- Samaritans
- Alzheimer's Society
- NHS Sexual Health Services
- Public Health Swindon Borough Council

These sessions helped young people access trusted adults, specialist knowledge, and early intervention support.

Volunteer Development & Training

To ensure high-quality, safe, and informed youth work practice:

- Two volunteers completed Emergency Paediatric First Aid training (Wiltshire First Aid Training, November 2024)
- 5 Volunteers covered all group sessions throughout the year, all enhanced DBS checked and Advanced Safeguarding Level 2 trained.
- 1 JNC qualified Youth Worker attended a majority of the sessions.

This investment in volunteer skills strengthens safeguarding and ensures young people receive safe, reliable support.

Networking and Representation

OOTC continued to build relationships with regional and national LGBTQ+ networks. Notably:

- Two volunteers were invited to attend the Schools Out LGBTQ+ History Month 2025 Theme Launch at Conway Hall, London.

This reflects OOTC's growing reputation as a valued contributor to LGBTQ+ youth work and community development.

Impact Summary

Across 2024, OOTC:

- Provided 68 safe, inclusive youth sessions;
- Supported an average of 32 young people per week;
- Delivered a wide range of creative, educational, and wellbeing activities;
- Strengthened community partnerships and visibility;
- Maintained a committed volunteer team;
- Offered young LGBTQ+ people a space to belong, grow, and thrive;
- Out of the Can transitioned to a Charity, after existing as an unincorporated association for over 20 years.

The Trustees are proud of the resilience, creativity, and dedication shown by staff, volunteers, and young people throughout the year. OOTC continues to play a vital role in supporting LGBTQ+ youth wellbeing across Swindon and Wiltshire.

Financial Review

In terms of looking forward OOTC will be applying for further grants in 2025 from BBC Children in Need and The National Lottery Community Grant. Along with seeking further corporate donations (previously OOTC has been successful with Thames Water and WHSmith). OOTC is also part of the Swindon Community Lottery, which is planned to be pushed as part of our Social Media Campaign).
