**Objects:** THE OBJECT OF TOGETHER FOR THE CHURCH OF ENGLAND IS THE ADVANCEMENT OF THE CHRISTIAN FAITH BY PROMOTING GREATER INCLUSION AND EQUAL OPPORTUNITY TO PARTICIPATE IN THE LIFE OF THE CHURCH OF ENGLAND FOR ALL, REGARDLESS OF ETHNICITY, DISABILITY, SEX, GENDER, GENDER IDENTITY, SEXUALITY, MENTAL HEALTH, NEURODIVERSITY, MARITAL STATUS, SOCIO-ECONOMIC BACKGROUND OR ECONOMIC POWER. THIS OBJECT MAY BE SUPPORTED BY: A) ENCOURAGING BROAD AND DIVERSE PARTICIPATION WITHIN THE GOVERNANCE STRUCTURES OF THE CHURCH OF ENGLAND; B) WORKING FOR EQUITY WITHIN THE CHURCH OF ENGLAND AND COUNTERACTING DISCRIMINATION; AND C) SUPPORTING AND ENCOURAGING AN INCLUSIVE, PUBLIC FACING AND AFFIRMING EXPRESSION OF THE CHRISTIAN FAITH WITHIN THE CHURCH OF ENGLAND.

**Activities:** we are aiming to encourage broad and diverse participation within the governance structures of the Church of England; Working for equity within the Church of England and counteracting discrimination; and Supporting and encouraging an inclusive, public facing and affirming expression of the Christian faith within the Church of England.
