THE RELIEF OF THE SICK AND THOSE SUFFERING FROM PHYSICAL, EMOTIONAL OR MENTAL DISABILITY OR IMPAIRMENT; AND 3. ENABLING THOSE IN NEED OF ACCESS TO FACILITIES OF THE TYPES DESCRIBED IN SECTION 5 OF THE CHARITIES ACT 2011 TO ACCESS SUCH FACILITIES.

Activities: To provide assistance in the most appropriate way (financial, personal, signposting etc) to persons of the Jewish faith and their families who are resident in or around Bournemouth, Poole and Christchurch as well as the immediate surrounding areas.
