Financial Review

During the reporting period ending 1 April 2025, the charity received total income of £5,939, primarily from donations and voluntary contributions. Total expenditure during the period was £4,892, which was applied towards supporting the charity's activities and operational costs. The charity recorded a surplus of £1,047 for the period. The trustees ensure that appropriate financial controls are in place to manage the charity's funds responsibly.

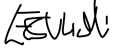
1. Basis of preparation: Accounts are prepared on a receipts and payments basis.
