General public:

Public performances from the band offer opportunities to the public maintaining their education and appreciation of music. Performances challenge and educate audiences offering in social experiences and exposure to live music.

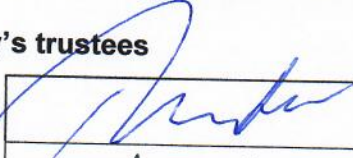
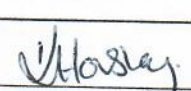
