REPORT OF THE TRUSTEES

FOR THE YEAR ENDED

31ST OCTOBER 2025

The trustees, who are also directors of the charitable company for the purposes of the Companies Act 2006, present their report with the financial statements of the charitable company for the year ended 31st October 2025. The trustees have adopted the provisions of Accounting and Reporting by Charities Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102 - effective 1st January 2015).

Charity Status

On 11th September 2024 the company, Cool to be Kind Ltd, was registered with the Charity Commission. It is now designated as a Charitable Company, where previously it was solely a company limited by guarantee. Prior year figures have been restated in the correct format for a charitable company to aid comparison.

Objects of the Charity, Principal Activities and Organisation of our work

The charity is constituted as a company limited by guarantee, and is therefore governed by a memorandum and articles of association.

The charity's objects are for the alleviation and relief of people who are homeless, at risk of homelessness, experiencing financial hardship or in need by reason of other vulnerabilities in England, and especially Essex, including but not exclusively, through:

- (1) providing essential items necessary to relieve or prevent their homelessness, risk of homelessness, financial hardship or other vulnerabilities
- (2) providing advice, information and access to services which, directly or indirectly, relieves their homelessness, risk of homelessness, financial hardship or other vulnerabilities
- (3) educating and raising awareness of issues related to homelessness and other vulnerabilities through whatever means of publicity the charity deems fit.

The principal activities is to help and support people who are homeless, at risk of homelessness or experiencing financial hardship by providing essential items necessary for relief, provide advice, information and access to services which relieves their homelessness, risk of homelessness, financial hardship or other vulnerabilities.

We raise awareness of issues related to homelessness and other vulnerabilities.

The board of trustees, who meet at least 4 times a year are responsible for the administration of the charity. The day to day management is the responsibility of Dan Skeates. Trustees are appointed by the existing board members and are drawn from interested members of the public.

The charity places much reliance on the services of unpaid volunteers. This includes the time provided by the Trustees.

Future Developments

We have secured funding for a storage unit and second hand van, which we are trying to find now. Essex County Council are keen for us to expand our services throughout Essex and we are currently creating a strategy to facilitate this.

Public Benefit

In setting its plans for areas of work, the Trustees of Cool to be Kind Ltd have had regard to the guidance from the Charity Commission on public statement of benefit. Cool to be Kind Ltd's business plan and the analysis of achievements against that plan demonstrates how Cool to be Kind Ltd has set out to fulfil its principle charitable objective that is the alleviation and relief of people who are homeless, at risk of homelessness experiencing financial hardship or other vulnerabilities.

Reserves Policy

The trustees have reviewed the charity's needs for its reserves in line with the guidance issued by the Charity Commission and have set aside or designated £5k to safeguard the charity's service commitment in the event of delays in receipt of grants or accrued legacies. This approximates to three months running costs plus closure costs. The Trustees believe that reserves should be at least at this level to ensure the charity can run efficiently and meet the needs of the beneficiaries.

Directors and Trustees

All directors of the company are also Trustees of the charity and there are no other trustees. The Trustees are named on page 1.

STATEMENT OF DIRECTORS' RESPONSIBILITIES

The directors are responsible for preparing the financial statements in accordance with applicable law and UK Generally Accepted Accounting Practice.

The Companies Act 2006 requires the directors to prepare financial statements for each financial year which give a true and fair view of the state of the company and of its profit or loss for that period.

In preparing those financial statements the directors are required to:-

- (i) Select suitable accounting policies and then apply them consistently.
- (ii) Make judgements and estimates that are reasonable and prudent.
- (iii) Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The directors are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the company. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

1 Accounting policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and in the preceding year.

a Basis of accounting

The financial statements have been prepared under the historic cost convention and in accordance with the Charities SORP (FRS102) Accounting and Reporting of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2015) and the Companies Act 2006.

b Fund accounting

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.
The Trustees are named on page1.

c Incoming resources

Voluntary income, donations and grants are accounted for on an accruals basis.

d Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT that cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Direct charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the independent examiner's fees and costs linked to the strategic management of the charity.

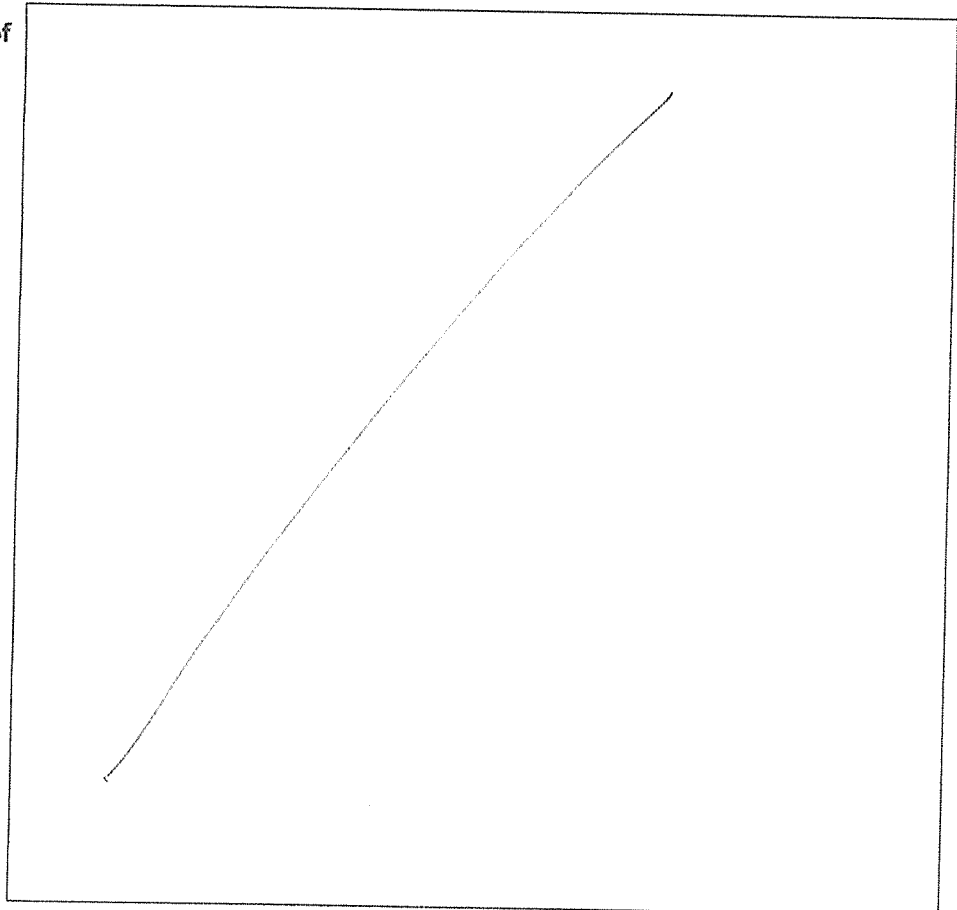
