SUCH OTHER MEANS AS MAY FROM TIME TO TIME BE DETERMINED SUBJECT TO THE PRIOR WRITTEN CONSENT OF THE CHARITY COMMISSIONERS FOR ENGLAND AND WALES.2. THE ADVANCEMENT OF THE ARTS, CULTURE AND HERITAGE, IN ALL ASPECTS BY ANY MEANS THE TRUSTEES SEE FIT, INCLUDING BUT NOT EXCLUSIVELY BY THE PRESENTATION OF PUBLIC EVENTS AND EXHIBITIONS, THE PRESERVATION OF BUILDINGS OR SITES OF ARCHITECTURAL AND HISTORIC INTEREST AND THE EDUCATION OF THE PUBLIC ON THE HISTORY, ART, ARCHITECTURE, TRADITIONS AND CULTURE OF THE AREA OF BENEFIT.3. TO FURTHER SUCH CHARITABLE PURPOSE OR PURPOSES THAT THE TRUSTEES IN THEIR ABSOLUTE DISCRETION SHALL THINK FIT, PARTICULARLY THROUGH THE MAKING OF GRANTS, BURSARIES AND DONATIONS.
