Church Council

The Church is overseen by a council of members who are elected by the general body. The council works closely with the Pastor to provide leadership and direction for the Church's activities and ministries. Regular meetings are held to review and assess all Church activities, ensuring that any concerns or areas for improvement are identified and addressed promptly. Necessary changes are implemented for the benefit of the Church, its members, the wider community, and the nation.

The Church council is responsible for the overall governance of the Church, while the day-to-day management is carried out in collaboration with the Pastor. Financial matters are managed by the treasurer, and the Church accounts are regularly reviewed and audited to ensure transparency and accountability.

Summary of Charitable Activities for 2024-25

The church actively supported the community by providing financial assistance to three individuals who were facing hardship. We also engaged in street evangelism, reaching out to the public in Middlesbrough and distributing 75 gift boxes to bless those in need. - to state whether matters have come to my attention.

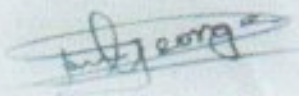
Basis of the independent examiner's report:

The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a 'true and fair view' and the report is limited to those matters set out in the statements above.

Financial Review

The gross income for the year ending 31st March 2025 was £54,166. Total resources expended during the year amounted to £23,184 resulting in a surplus of £30,982

Public Benefit

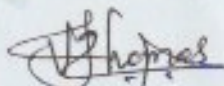
Risk Management

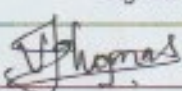
