Activities: Conducting public church services, weddings, funerals and baptisms; children's and youth work; ministry to elderly; outreach to encourage learning about the Christian faith; ministries to internationals in Cambridge; pastoral ministry to members and attenders in need; small groups to facilitate Bible study and community; supporting Christian individuals and organisations in the UK and overseas.
