1. Structure, Governance and Management

a) Governing Document

The charity was registered as a CIO on 30th September 2024

b) Appointment of Trustees

All current trustees were appointed on 30th September 2024. Nicholas Richley, Francis Richley and Arpana Paterson were appointed for a period of four years, all other Trustees for a period of three years.

Apart from the first charity trustees, every trustee must be appointed for a term of three years, by a resolution passed at a properly convened meeting of the charity trustees.

In selecting individuals for appointment as charity trustees, the charity trustees must have regard to the skills, knowledge and experience needed for the effective administration of the CIO.

The charity trustees will make available to each new charity trustee, on or before his or her first appointment:

- a copy of the current version of this constitution; and
- a copy of the CIO's latest Trustees' Annual Report and statement of accounts

c) Policies

In the first six months of the charity being established, the following policies have been written and approved by trustees:

- Safeguarding Policy
- Code of Conduct Policy
- Fundraising Policy
- Conflict of Interest Policy
- GDPR Policy
- Sexual Harassment Policy
- Volunteering Policy
- Whistleblowing Policy

d) Brand and Marketing

Significant work has been invested into establishing the Alfie Nick Foundation brand, website and other communication channels. This work has been completed professionally with no costs incurred to the charity.

2. Objectives and Activities

The charitable objectives of the foundation are:

The relief of children, and by extension their families/carers, in need by reason of ill-health, disability (mental or physical), financial hardship or other social disadvantage resulting from being in the care of local authorities as a 'looked after child' at any point in their lives, through the provision of grants of financial assistance to obtain such items, services, activities and support required to enable them to develop and thrive.

3. Achievements and Performance

During the first six months, the charity concentrated on laying its foundations by setting up governance structures, initiating its inaugural fundraising campaign, and forging partnerships with local organisations. Most importantly, we were able to fund therapeutic support for our first wave of children.

a) Governance

Trustee's meetings are held every 6-8 weeks, and initial meetings enabled the charity to outline its mission and goals and form its initial policies and procedures.

b) Fundraising and Fundraising Strategy

Planning towards the inaugural fundraising event at the ICC Wales has been a major focus – the event is to be held in May 2025. Sponsorship for this event is being found locally so that all ticket sales will go directly to the objectives of the charity.

Signature fundraising events include The Three Peaks Challenge (April 2025) and a Kilimanjaro climb (June 2025) – these events have also been part of the trustee's discussion. Individuals taking part in these events are entirely self-funded, ensuring that all monies raised go directly to the charity objectives.

Regular donations will be the main means of day-to-day support for the charity as will one-off donations. Just Giving pages and a PayPal account have been set up for this purpose.

c) Partnerships

Partnerships have been agreed with the following organisations:

- Move the Mind CIO (Hoare's Lane, Frome) who provide animal therapy for children with severe disabilities. Initial weekly therapeutic sessions for two children have been supported financially.
- Urban Pursuit (Avon Quay House, Bristol) who are aligned with the charity in mission and purpose and their heart is to help children who are at risk of exclusion, hidden disabilities, inability to access the curriculum. We have agreed to pilot a programme of

support for children at Winterbourne Academy, Bristol (high risk children identified by the school).

- Leaf Trust Bristol – meetings with the Executive Team have taken place to establish collaboration and support opportunities for 2025.

Several other partnership opportunities are being established and will be reported in the next TAR.

d) Support

We are delighted to have supported our first number of disadvantaged children in the early days of establishing the Foundation. Impact statements and feedback from partners, care professionals, families and children, where appropriate, is shared with Trustees.

4. Financial review

At the end of this financial period, monies held in the bank amounted to £38,434.12.

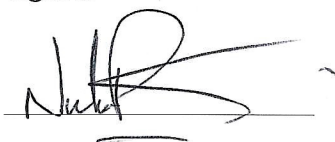
Revenue is made up of individual donations and fundraising activities including sponsorship for the planned events.

Operational costs are minimal and have been funded through restricted funds, given specifically for this purpose, ensuring that all donations received go directly to supporting children.

The most significant outlay is for the launch event (16th May 2025) which is to be hosted at the ICC Wales. All costs relating to the event will be covered by 3 event sponsors and ticket sales, ensuring the charity does not incur costs and all remaining proceeds go directly to our charitable cause.

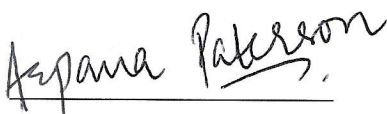

Going forward the trustees will be recognising restricted reserves to cover certain projects or investments. As at 05.04.2025, these were identified as totalling £1,000 for the general operational costs based on a one-off grant, which was used, in part, for promotional items in the year with the remainder carried forward.
