**TRUSTEES' REPORT**

The trustees present their report and accounts for the 330 day period ended 01/09/2025

**PRINCIPAL ACTIVITIES**

The principal activity of the charity in the 330 day period under review was that of general charitable purposes, education/training, disability and the prevention or relief of poverty. .

**ACHIEVEMENTS AND PERFORMANCE**

2.1 Support to Tiafi Community Centre

- Provided essential financial support for the first six months of the year, enabling Tiafi to remain open until June 2025. Without our support, the centre would have closed in January 2025.
- Tiafi offered a broad range of services to refugees living in poverty. Over eight years, the front-line manager recorded more than 17,000 individual contacts, providing advice, guidance, and practical support.

2.2 Support to a General Surgeon in Training

- Assisted a Syrian general surgeon seeking recognition of his Egyptian medical qualifications in Turkey. Funding covered fees required for his unpaid internship.
- Upon completion, he will practise as a general surgeon, providing vital medical care to the community.
- The General Surgeon volunteered at weekends, visiting refugees without access to healthcare. Translator Bassel facilitated his access to camp locations and relevant communities.

**STRUCTURE GOVERNANCE AND MANAGEMENT**

- In February, Whin Trust subscribed to Compliance Assist, providing due-diligence screening including AML, sanctions, PEP, and adverse-media checks. This service screens trustees of supported organisations and translators.
- Trustee David Hayward attended two Charity Commission events:
  - \* 15 April 2025 - Webinar for small international charities covering trustee responsibilities, banking, compliance tools, audit trails, and reporting serious incidents.
  - \* 19 August 2025 - Event in Manchester titled "World: Working Overseas - Risks, Responsibilities and Legal Duties," providing guidance for overseas activities.
- These engagements support the Trust in maintaining high standards of governance and regulatory compliance.

**ONGOING WORK AND FUTURE PLANS**

- Whin Trust continues to support grassroots organisations assisting refugees in Izmir.
- Currently supporting Yasamak, an organisation that provides legal, medical and psychosocial support to refugees and those in need.

**1. ACCOUNTING POLICIES**

**1a. Basis Of Accounting**

The accounts have been prepared under the historical cost convention.

The accounts have been prepared in accordance with FRS102 - The Financial Reporting Standard applicable in the UK and Republic of Ireland and the Companies Act 2006 and the requirements of the Statement of Recommended Practice, Accounting and Reporting by Charities.

**1b. Incoming Resources**

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

**1c. Resources Expended**

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

**1d. Allocation And Apportionment Of Costs**

All costs relate to the single activity of the charitable company and are recognised accordingly.

**1e. Fund Accounting**

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Designated funds are funds set aside by the trustees out of unrestricted general funds for the specific future purposes or projects.
