Report of the Trustees for the Period 1st April 2025 to 31st December 2025

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the period 1st April 2025 to 31st December 2025. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

To promote the benefit of the inhabitants of Heene Municipal Ward and the neighbourhood in Worthing, West Sussex, by associating together the said inhabitants and the local authorities, voluntary and other organisations in a common effort to advance education and to provide facilities in the interests of social welfare for recreation and leisure-time occupation with the object of improving the conditions of life for the said inhabitants;

To establish, or secure the establishment of, a Community Centre and to maintain and manage the same in furtherance of these objects.

Significant activities

This is the first period for the Centre since converting from an un-incorporated charity.

The Centre is a very popular community hub offering a wide range of activities to individuals and groups of all ages. Such as ballet, yoga, short mat bowls, painting classes, language classes, health & wellbeing. The centre also hosts classes run by external organisations such as the NHS for young mothers, first aid training, and cardiac rehabilitation. The Centre also has its own Cafe which has proved very popular and is often full to capacity, being used by both Centre users and the general public.

Public benefit

The trustees have considered the Charities Commission general guidance on public benefit when reviewing the aims, objectives and planned activities of the charity.

ACHIEVEMENTS AND PERFORMANCE

Summary of the main achievements of the charity during the year

The Heene continues to be a thriving Community Centre.

There was a major change to the legal structure of The Heene, so we are now a company limited by guarantee and therefore our charity number had to change.

The in house Café was still very busy, providing a friendly welcoming environment for users and hirers of all ages. New chairs were purchased, giving it a more modern look. To accommodate the increasing numbers, planning permission was sought and granted for a Conservatory extension to the Café area. The building work for this started in December.

The Easter Raffle, raised £512 & was hugely popular, with our chocolate lovers!

There was no Summer Fayre this year, due to a lack of volunteers but The Christmas Fayre was as popular as ever, raising £2500.00.

Following the revamp of the garden area last year, there was a major overhaul of the garden beds. These were planted with wild flowers and Agapanthus.

Routine maintenance took place throughout the year. 45 purple chairs were purchased using a Grant from Chalk Cliff Trust. Room bookings remain at a very healthy level.

As a reward for those who have become members, we offered a monthly prize draw, which proved popular so will continue next year.

FINANCIAL REVIEW

Financial position

The charity in line with the charities commission guidance on reserves holds six months reserves against all eventualities. These reserves are held in bank deposit accounts

Independent examiner's report to the trustees of Heene Community Association Ltd ('the Company')

I report to the charity trustees on my examination of the accounts of the Company for the period 1st April 2025 to 31st December 2025.

Responsibilities and basis of report

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Improvements to property	- 10% on cost
Sports equipment	- 20% on cost
Fixtures and fittings	- 20% on cost
Equipment	- 20% on cost

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.
