Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	<p>During 24-25, FOLF organised the following fund raising and social events: Scaries & Faries Discos, Pre-loved Toy Sale, Christmas Discos, Bingo & Film Night, Duck Race, Smarties Challenge, refreshments & uniform sale at Sports Day, Summer Festival and refreshments at Year 6 Leavers' BBQ. As well as raising funds, they provided great opportunities bring the school and local community together.</p> <p>Events raised £10,475 towards Bronwen's Wish project, which will see the introduction of an outdoor learning & wellbeing pod in 25-26 school year.</p> <p>Rock School was the activity receiving the most significant contribution from FOLF during the year. Rock School gives access a variety of activities to enhance the children's experience in areas such as music, singing drama, art and dance. Opportunities were extended to children in Dosbarth Enfys by funding a silent Disco and Little Fizz music sessions.</p>

Performance of fundraising activities against objectives set	Fundraising during 24-25 exceeded expectations for the year, and was also in excess of amounts raised in previous years. The target fund raise towards the Bronwyns W;sh project was reached before the end of the school term, much faster than anticipated, allowing the project to proceed during 25-26.
Investment performance against objectives	Cash held in new FOLF bank accounts now earn interest.
Other	FOLF became a registered charity during the year and has benefited from a grant of £500.

Financial Review

Review of the charity's financial position at the end of the period	Cash at the bank at 31/08/2025 was £33,361, of which: £10,475 is funds raised for the Bronwyn's W;sh project, which will progress in 25-26. £3,176 is funds held for use on animal enclosures. This does not include the £500 grant awarded towards this project as the cash was received after the year end. The rest of the funds are unrestricted. Operating costs of FOLF are minimal at around £200 a year covering insurance and ParentKind membership.
