- Rub-A-Dub Pre-School was registered as a CIO on 4th November 2024. It started trading as a CIO on 29th June 2025.
- In those 5 weeks before the summer holiday, we continued to provide excellent care and ensure transitional arrangements for those moving on to school in the new academic year.

Financial review

Brief statement of the charity's policy on reserves

Ofsted advise a cash reserve of 1/3 of a year's expenditure. Year-end General cash reserve was £72118.11 for this first trading period. For any periods where the pre-school operates with a deficit of receipts over payments this reserve is used to allow the pre-school to continue to operate for a period whilst steps are taken to eliminate the operating deficit. This reserve also acts as a contingency against closure where staff notice and redundancy pay would need to be paid along with notice period to the Lansdowne Hall (the pre-school setting). Redundancy and closure costs are held in separate savings accounts from the general expenditure accounts (Lloyds). The amount in the Lloyds instant access account for this year is £49978.78. Total in the Lloyds accounts for this year is £20704.31


