TO PRESERVE AND PROTECT THE HEALTH OF THE GENERAL PUBLIC IN ACCRINGTON BY PROVIDING PRACTICAL ADVICE AND SUPPORT TO USERS OF THE NIGHTTIME ECONOMY TO ENABLE THEM TO STAY SAFE.

Activities: Accrington Christians Together run a number of initiatives in the town of Accrington. We operate a Foodbank for local people in need and run the ACT Street Angels, looking after the vulnerable and helping to keep the streets safe. On every first and third Wednesday we operate a prayer meeting in local cafes. Each Thursday we run a bible study group in a local cafe for anyone seeking faith.
