Summary of the main achievements of the charity during the year

This was the charity's first reporting period following registration with the Charity Commission on 5th December 2024. During the year, the trustees established the charity's banking and financial systems and began delivering overseas charitable programmes focused on poverty relief and supporting those in hardship across Pakistan, Malawi and Egypt.

Activities included the provision of clean water facilities, food aid, blankets, educational materials, the construction of a community centre, support for an organisation assisting refugee children, and seasonal Qurbani meat distributions to families in need.

The charity worked with UK-registered partner charities and directly with beneficiaries to ensure funds were applied for their intended charitable purposes.

The trustees also implemented governance policies and adopted an evidence-based approach, obtaining photographic, video, and written evidence to monitor project delivery and provide assurance to donors and trustees.

The trustees believe these activities provided clear public benefit through the relief of poverty and the provision of essential support including food, water, shelter, education, and community facilities.
