THE ADVANCEMENT OF THE CHRISTIAN FAITH, PRIMARILY (BUT NOT EXCLUSIVELY) ACROSS STOCKPORT, FOR THE PUBLIC BENEFIT, BY MEANS OF BUT NOT EXCLUSIVELY: (A) OPERATING AS A STEERING AND ADVISORY GROUP ASSISTING LOCAL CHURCHES AND RELIGIOUS ORGANISATIONS TO ENLIGHTEN OTHERS ABOUT THE CHRISTIAN FAITH; (B) DELIVERING ACTIVITIES BOTH DIRECTLY AND IN PARTNERSHIP WITH OTHER ORGANISATIONS AND INDIVIDUALS TO PROMOTE THE CONTINUOUS AWARENESS AND PRESENTATION OF THE GOSPEL OF JESUS CHRIST. II. THE RELIEF OF NEED AND THE RELIEF OF UNEMPLOYMENT AMONG PERSONS WHO ARE SOCIALLY OR ECONOMICALLY DISADVANTAGED, INCLUDING PERSONS SUFFERING FROM DRUG OR ALCOHOL ABUSE OR SIMILAR PROBLEMS AND REFUGEES AND THOSE SEEKING ASYLUM, BY MEANS OF BUT NOT EXCLUSIVELY: (A) PROVIDING THERAPY OR BY SHARING WITH THEM THE CHRISTIAN FAITH, PRINCIPLES AND VALUES; (B) ADVANCING THEIR EDUCATION SO AS TO BETTER ENABLE THEM TO COPE WITH THE BUSINESS OF LIFE AND PROMOTE THEIR MENTAL AND PHYSICAL REHABILITATION; (C) THE PROVISION OF VOCATIONAL AND SKILLS TRAINING, ADVICE AND SUPPORT.
