Objects: 1. FOR THE PUBLIC BENEFIT, TO RELIEVE POVERTY AND FINANCIAL HARDSHIP OF PET OWNERS, PRIMARILY IN GREATER MANCHESTER WHO ARE UNABLE TO FEED DOMESTIC ANIMALS THEY ARE RESPONSIBLE FOR BY THE PROVISION OF FOOD FOR DOGS, CATS AND SMALL DOMESTIC ANIMALS AND FUNDING FOR VETERINARY COSTS WHICH THEY COULD NOT AFFORD THROUGH LACK OF MEANS.2. FOR THE PUBLIC BENEFIT TO RELIEVE THE SUFFERING OF ANIMALS IN NEED OF CARE ATTENTION, IN PARTICULAR THROUGH THE PROVISION OF AWARDED GRANTS FOR ANIMAL HEALTHCARE, FOOD AND RESOURCES TO ANIMAL WELFARE CHARITIES OR OTHER FACILITIES/ORGANISATIONS WITHIN ENGLAND AND WALES THAT FURTHER THAT CHARITABLE PURPOSE.3. FOR THE PUBLIC BENEFIT, TO RELIEVE POVERTY OR FINANCIAL HARDSHIP, PRIMARILY IN GREATER MANCHESTER THROUGH THE PROVISION OF FOOD.4. TO PROMOTE FOR THE PUBLIC BENEFIT, THE CONSERVATION, PROTECTION AND IMPROVEMENT OF THE PHYSICAL AND NATURAL ENVIRONMENT IN PARTICULAR BUT NOT EXCLUSIVELY BYA) PROMOTING AND FACILITATING PRACTICAL MEASURES SUCH AS ARRANGING COMMUNITY CLEAN UPS AND LITTER PICKING ACTIVITIES;B) RAISING PUBLIC AWARENESS RELATING TO ENVIRONMENTAL MATTERS;C) SUCH OTHER WAYS AS THE TRUSTEES MAY DETERMINE.
