THIS SHALL BE, FOR EXAMPLE, REGARDLESS OF AGE, SEX, ETHNIC ORIGIN, RELIGION, DISABILITY OR POLITICAL PERSUASION, ON ANY GROUNDS.(B) THE CIO SHALL NOT APPLY NOR ENDORSE UNLAWFUL OR UNJUSTIFIED DISCRIMINATION AND SHALL ACT IN COMPLIANCE WITH THE PROTECTIONS AFFORDED BY THE EQUALITY ACT 2010 (AS MAY BE AMENDED FROM TIME TO TIME).(C) THE CIO SHALL IMPLEMENT THE SWIM ENGLAND EQUALITY POLICY (AS MAY BE AMENDED FROM TIME TO TIME).(D) THE CIO WILL COMPLY WITH THE DATA PROTECTION ACT 2018 (AS MAY BE AMENDED FROM TIME TO TIME).
