**Objects:** TO RELIEVE THE NEEDS OF YOUNG MEN [UP TO THE AGE 25], PRIMARILY IN GLOUCESTERSHIRE, WHO ARE EXPERIENCING OR MAY BE AT RISK OF EXPERIENCING POOR MENTAL HEALTH, IN PARTICULAR BUT NOT EXCLUSIVELY, THOSE WHO HAVE/MAY HAVE, NEURODIVERGENT CONDITIONS BY MEANS OF, BUT NOT LIMITED TO: A) RAISING AWARENESS AND PROMOTING UNDERSTANDING OF BOTH, YOUNG MEN'S MENTAL HEALTH, AND NEURODIVERSITY, AND CHALLENGING STEREOTYPES AND STIGMA IN THESE AREAS; B) PROVIDING OPPORTUNITIES FOR YOUNG MEN TO ACCESS SUPPORT; C) WORKING IN PARTNERSHIP WITH OTHER MENTAL HEALTH CARE PROVIDERS AND CHARITIES TO ADVANCE MENTAL HEALTH AWARENESS AND SUPPORT WITHIN THE COMMUNITY;
