2 STATEMENT OF TRUSTEES' RESPONSIBILITY

The Trustees are responsible for preparing the Trustees Annual Report and the financial statements in accordance with applicable law and regulations.

Law applicable to charities in England and Wales requires the Trustees to prepare financial statements for each financial year. Under that law the Trustees have elected to prepare the financial statements as explained below. They have general responsible for taking such steps as are reasonably open to them to safeguard the assets of the charity and to prevent and detect fraud and other irregularities.

3 OBJECTS AND PUBLIC BENEFIT STATEMENT

The objects of Hurst Hedgehog Haven is to promote first aid, kindness and to prevent or suppress cruelty to animals by all lawful means.

The Trustees have reviewed the outcomes and achievements of the objectives and activities for the year, to ensure they remain focused on the charitable aims, and continue to deliver benefits to the public. They have complied with their duties under the Charities Act 2006 to have due regard to public benefit guidance published by the Commission.

3.1 Advancement Of Animal Welfare

Under the Charities Act 2006, the advancement of animal welfare is recognised as a distinct statutory charitable purpose. This legislation and the Animal Welfare Act of the same year indicate an acceptance by society that treating living creatures with compassion has a moral benefit for the public as a whole. Whilst this public benefit is clear, it is sometimes difficult to quantify and must be balanced against any detriment.

3.2 Advancement Of Animal Welfare

We support our local community by offering rescue, first aid, care and take to the nearest vet, as well as providing education, information and advice on Hedgehogs in distress and enforce laws against cruelty.
