Trustees Report

Structure and Governance

The governing document of Clayton Baptist Church is the Church Constitution; the latest version being agreed by the church members in 2020. The Charity Trustees include a Minister and Deacons who are elected by members of the church at Ordinary Church Meetings (also known as Church Forums). The constitution states that a majority of the Charity Trustees must have been baptised by immersion. The Charity Trustees have delegated day-to-day responsibility for making decisions, but they are accountable to the church members who are responsible for making decisions at Ordinary Church Meetings.

The Charity Trustees met eleven times to discuss the business of the church in 2025. There were five Ordinary Church Meetings, one which included the Annual General Meeting.

Objectives and Activities

The principal purpose of the Church is the advancement of the Christian faith according to the principles of the Baptist denomination. The Church may also advance education and carry out other charitable purposes in the United Kingdom and/or other parts of the world.

The Charity Trustees along with the congregation are responsible for advancing the Christian faith and promoting the whole mission of the church including evangelism and Christian discipleship, education, pastoral, social charitable action and encouraging relationships with and supporting Baptists and other Christians.

The church agreed a 5 year vision in 2022 titled 'Forging for Fruitfulness' and under this title for 2025 three objectives were discerned:



Public benefit statement

In setting our objectives and planning our activities our trustees have given serious consideration to the Charity Commission's general guidance on public benefit and in particular advancement of the Christian faith.

Ministry

The paid ministry team comprises of Revd Kenny Brown, Minister (Part-time 0.8 whole time equivalent) and Lucy Brown, Children's and Families worker (Part-time 0.4 whole time equivalent).

Membership

As of 31 December 2025, CBC had 42 members, but many more people attend services and the wider midweek activities the church provides.

Church services

Sunday morning services continue to be the primary gathering point of the congregation each week. There has been an increase in average attendance this year including in the number of children and young people attending for which we are thankful to God. There was one child dedication this year which was the first in over two years. Many congregants use their gifts during services for the benefit of everyone. Some examples are preaching, leading prayers and services, operating the sound and vision equipment and playing musical instruments. Specific support was given to musicians who are part of the church to encourage and equip them to lead sung worship in services which has been greatly encouraging to the congregation.

In February we continued our practice to mark Racial Justice Sunday using some of the resources from Churches Together in Britain and Ireland and in November for the first time CBC marked Disability Awareness Sunday where feedback from the congregation was sought leading to some changes being made related to the readability of our visual resources.

The cycle of Sunday services changed to include a monthly interactive 'Discovery Sunday' which involves Lego, Art and a Discovery Bible Study that the whole congregation get involved in together and it has been so encouraging to see the creative talents of all ages.

Congregants were encouraged to engage with the CBC Big Read which involved reading through the New Testament in one year through 2025.

Children's, Youth and Families work

Lucy Brown, CBC Children's and Families worker alongside committed volunteers facilitates 'mainly music' and 'Explore & Play' groups for 0-5's and parents/carers, and a youth group for 11-16's. Lucy has continued to provide wonderful support to Clayton St John's primary school by delivering regular collective worship, relational support and being a School Governor.

Other activities

Notable other events during the year was the Good Friday Tenebrae service, summer café, Carnival of Light and the CBC Nativity service. A number of life-groups met in homes and online. In 2022 the church started Thrive in the Thornaby area of Clayton with a vision to eventually establish a worshipping community there. Unfortunately, that vision has been unable to come to fruition due to circumstances outwith our control. This has resulted in the church no longer providing volunteers but we are thankful for what we learned and the relationships formed.

Church building

The church building continues to be used for the wider public benefit through pre-school groups (mainly music, Explore & Play) operated by the church whose attendees come from Clayton and surrounding communities and through hiring the space to community groups such as a Scouting group, the Zion congregation who do not own a building, and a weight loss business.

Wider Baptist life

We have been involved in the Yorkshire Baptist Association (YBA) Inter-ethnic learning community this year and in late 2025 Kenny participated in the first YBA Church Planting collective. CBC has also actively supported the YBA by continuing to release Kenny to be a Trustee and an active member of the YBA Ministries group.

Alleviating the impact of poverty

We had one appeal this year at Harvest to raise money for the Bradford Baby Bank and Zarach (www.zarach.org) charities who are seeking to alleviate the suffering of those in poverty. The church agreed to continue to raise money for Zarach through 2026 who serve to alleviate bed poverty.

A communion offering is taken up each month during a Sunday service and monies that are donated are used for needs amongst our congregants and wider communities when those needs are reported to the Minister/Trustees.

Pastoral Care Team

There are a team of church members who proactively and reactively provide care to congregants but caring for each other is everyone's responsibility and care happens through midweek groups, friendships and in other ways.

The team facilitated 3 lunches in 2025 aimed at people who felt new to CBC. We felt this was needed due to the numerical growth we experienced in our Sunday congregation. 27 people attended which was a testimony to the growth that we have had, and there were others who were unable to attend.

Safeguarding

Safeguarding children, young people and adults at risk is important to us and our policy and procedure is publicly available on our website and in the church building with further copies available on request. Volunteers and paid staff undergo a Disclosure & Barring Service (DBS) check and receive safeguarding training. We have a Safeguarding Trustee and Designated Person for Safeguarding (DPS) in place.

Discovering Jesus *and* helping other people discover who Jesus is

Early in 2025 two church members travelled to India with the YBA to experience Disciple Making Movement principles in real life. The impact of this experience has seen a significantly positive and exciting change in the life of the church with the development of four discovery bible study groups where Christians and non-Christians are exploring faith and growing in faith.

In late 2025 we held 'Exploring Baptism' sessions and also launched our 1-1-1 Prayer initiative which encouraged congregants to pray for 1 person for 1 minute at 1pm each day, praying for people to come to faith and opportunities to discuss faith and read the Bible together.

Going forwards - 2026

Due to the growth that we have blessed with, we are reviewing our church structures and operations under the banner of 'Shared Stewardship' to enable us to build and support everyone well in growing in faith. We are also praying and reflecting on what it means to multiply; being disciples who make disciples; and will be exploring developing Discovery Bible Study groups in other locations where congregants have existing relationships. A team of coaches trained by TLG will be starting Early Intervention coaching in the school once they have been trained by TLG and safeguarding processes have been completed.

Financial review

All assets of Clayton Baptist Church are used for the direct charitable purposes of the Church. The trustees consider that the financial position at the Balance Sheet date is satisfactory, and the Church is able to meet future obligations. During the year Clayton Baptist Church had total receipts of £76457.79 and payments of £69265.81, resulting in a net surplus of £7191.98

Reserves Policy

The Trustees consider it prudent to hold in reserve an amount equivalent to 3-4 months of the running costs of Clayton Baptist church in order to be able to adapt to any changes in the income and expenditure of the church. As of 31 December 2025, the unrestricted free reserves are: £24730.97

TRUSTEES' RESPONSIBILITIES

They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Independent Examiners' Report

Report of the Independent Examiner(s) of the Trustees of Clayton Baptist Church

On the accounts for the year ended 31st December 2025

Respective responsibilities of Trustees and Examiner
