Foreword

The world's children are facing challenges that feel both vast and urgent. Conflict, climate change, the mental health crisis, and deepening inequality do not stop at borders, and neither does the determination of young people to be heard, to lead, and to build something better. It is in that spirit that KidsRights UK was born.

Launching in the United Kingdom is part of something bigger. For KidsRights, establishing a presence here represents a significant step in growing our international reach - connecting our global mission to new audiences, new partners, and new supporters who share our belief that children's rights must be at the heart of how we build the world. The UK offers an extraordinary platform: a vibrant civil society, a global network of influence, and a strong tradition of international philanthropy. Being here allows us to amplify the work of KidsRights worldwide, and to bring more people (donors, advocates, policymakers and changemakers) into a movement that is already making a real difference.

But this is not only about reach. It is also about the young people across the UK who deserve to be part of that movement. We have already encountered children and young people here who are not waiting for permission to lead. They are speaking out on mental health, challenging inequality, and demanding that their voices carry real weight. KidsRights UK will be a home for them too.

We are building something here with real ambition and real excitement: partnerships, programmes, and a growing community of supporters who understand that investing in children's voices produces lasting change. Every connection we make in the UK strengthens the wider KidsRights mission: to ensure that children everywhere are heard, protected, and empowered to shape their own futures.

We are deeply grateful to everyone who has believed in this from the start. This is only the beginning and the potential ahead of us is extraordinary.

Because when children and young people are given the space, the tools, and the belief that their voices count, real and lasting change follows.

INTRODUCTION

This report marks the first few months of activity for KidsRights UK, reflecting both our establishment as an independent UK charity and our place within the wider KidsRights movement.

To provide clarity and context, this report is structured in two parts.

Part One offers an overview of the broader KidsRights Foundation, established in the Netherlands. It introduces the organisation's global mission to promote children's rights and amplify the voices of young changemakers, alongside its flagship programmes: the International Children's Peace Prize, the KidsRights Index, and State of Youth. This section provides important background on the international work and proven impact that underpin the KidsRights model, and which KidsRights UK is working to support, adapt and grow within the UK context over time.

Part Two presents the KidsRights UK Annual Report for 2025, outlining the charity's activities, achievements and progress during its first few months of operation. As a newly established organisation, 2025 has been a foundational year focused on building the charity's governance, operations, partnerships and foundations for programme delivery in the UK. This section clearly distinguishes KidsRights UK's own activities, highlighting the steps taken to establish a sustainable platform for future growth and impact.

Together, these two sections demonstrate how KidsRights UK is both rooted in a well-established global movement and developing its own distinct role within the UK. While our direct delivery in 2025 has been intentionally focused on the set-up and early-stage, it lays the groundwork for future expansion — including strengthening UK engagement with and support for KidsRights' global programmes.



PART 1: KIDSRIGHTS FOUNDATION

KidsRights has been working worldwide for the rights of the child for more than twenty years. Based on the conviction that children and young people not only deserve protection but are also powerful changemakers, we are building a world in which their voice has genuine influence. That mission is more urgent than ever.

At KidsRights, we believe that children have the right to be heard and actively involved in decisions that affect their lives and future, but also the right to express themselves and take action. These principles are enshrined in the United Nations Convention on the Rights of the Child and form the starting point for everything we do.

THE INTERNATIONAL CHILDREN'S PEACE PRIZE

The International Children's Peace Prize has grown over more than twenty years into the world's most important youth award. Since its founding in 2005 by Marc Dullaert and the official launch at the World Summit of Nobel Peace Laureates under the leadership of Mikhail Gorbachev, the prize has grown into a global platform for young changemakers who, with courage, vision and determination, stand up for children worldwide.

Each year, KidsRights receives hundreds of nominations from around the world. An independent international expert committee selects the winner based on impact, courage, leadership and commitment to children's rights. The prize is traditionally presented by a Nobel Peace Prize laureate.

The prize gives winners international visibility and concrete support to further develop their social initiatives. The winner receives the iconic Nkosi statue and a project fund of €50,000 for concrete initiatives that contribute to the position of children.

Desmond Tutu Study & Care Fund

To support winners in their personal and social development, KidsRights established the Desmond Tutu Study & Care Fund, named after patron Desmond Tutu. Through this fund, KidsRights supports laureates in accessing education and academic development. The fund also provides support to the winners' siblings.

With this, KidsRights invests not only in the social impact of today's young leaders, but also in their long-term future. Previous winners show what lasting impact looks like — they are building organisations and human rights platforms worldwide that reach hundreds of thousands of children.



The International Children's Peace Prize 2025

In 2025, we awarded the International Children's Peace Prize for the 21st time. This year the prize went to Bana Alabed, a 15-year-old Syrian living in Turkey who courageously gives a powerful voice to children in war zones. Worldwide, she drew attention to the suffering of Syrian children during the war, giving a voice to thousands of displaced children. Thanks to her tireless commitment, the International community was put under pressure to address the impact of war on children, and she was able to reach world leaders including President Macron, convincing them to advocate for ceasefires, protection of civilians and humanitarian solutions.

The Ceremony

The award ceremony took place in Stockholm City Hall. Guests from all over the world attended, including Her Royal Highness Princess Laurentien of Orange and Countess Eloise of Orange, representatives of children's rights organisations, diplomats, youth leaders and international media.

The ceremony was organised in collaboration with the Global Child Forum, founded in 2009 by the Swedish Royal Family.

The three finalists of this year were:

- **Aeshnina (Nina) Azzahra Aqilani (17, Indonesia)** fights against 'plastic colonialism' and advocates for environmental justice worldwide.
- **Divyansh Agrawalkoos (16, United States)** mobilises thousands of young people for climate policy, driving force behind 18 environmental laws.
- **Bana Alabed (15, Syria)** has become the voice of children in conflict zones, drawing on her own war experiences.

Winner 2025 - Bana Alabed

In her acceptance speech, Bana spoke emotionally about her childhood in Aleppo, the loss of loved ones and her determination to stand up for children without a voice. Her words drew prolonged standing ovations. Through international media, Bana's message reached more than 1.5 billion people around the world.

Bana grew up in the war and endured the siege of Aleppo in 2016, a period full of fear, loss and constant uncertainty. From a young age, she documented daily life in wartime through diaries, social media and her campaign 'Stand with Aleppo', which grew into a global movement with millions of participants.

She continues to focus her work on the devastating impact of war on children: lack of education, constant fear, trauma, insecurity and the loss of future prospects. Bana also continues to work tirelessly for the missing children in Syria, bringing hope and justice to families who have been living in uncertainty for years.

In addition to her activism, Bana is a respected young author and speaker. Through her books, articles, workshops and visits to refugee camps, she inspires young people worldwide to use their voices for peace, equality and protection of children's rights.

Bana's message has been widely taken up. From the Syrian government to the EU, Bana has been invited to speak. She recently spoke at the ECOSOC Youth Forum of the United Nations in New York, representing the voice of children and young people living in conflict zones.

Outside international policy forums, Bana's impact remained visible. Sky News made the documentary *World. War. Me.*, in which Bana shows how war affects the lives of children. The documentary won a BAFTA TV Award in May 2026 in the category Children: Non-Scripted.

THE KIDSRIGHTS INDEX



Children's rights form the foundation for the safe, healthy and just development of every child. With the ratification of the United Nations Convention on the Rights of the Child (UNCRC), virtually all countries in the world have committed to protecting and realising these rights. At the same time, practice shows that compliance with children's rights still varies greatly worldwide, and that millions of children are confronted daily with inequality, violence, poverty, limited access to education and healthcare, and insufficient opportunities to make their voices heard.

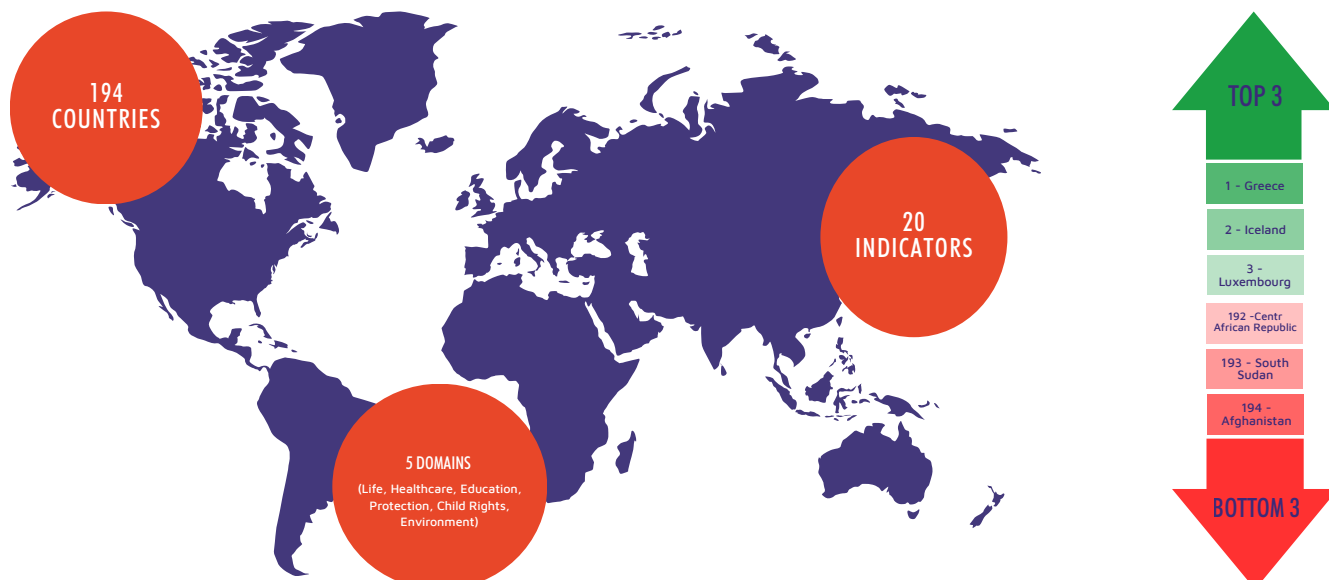
Driven by the conviction that children's rights must not only be enshrined but also genuinely upheld and strengthened, we developed the KidsRights Index. The KidsRights Index is the first and only global ranking that provides insight into how countries perform on children's rights, contributes to awareness, and encourages governments to place children's rights structurally higher on the political and social agenda.

The KidsRights Index offers concrete, evidence-based recommendations on how governments can improve their policies and performance on children's rights. The KidsRights Index is based on the near-universally ratified United Nations Convention on the Rights of the Child and provides an overview and ranking of the performance of countries that are party to the Convention.

In doing so, it looks at the most important aspects of children's lives for which comparable data are available worldwide.

In addition, the KidsRights Index makes use of recommendations from the UN Committee on the Rights of the Child, which monitors the implementation of the Convention on the Rights of the Child. The Committee assesses fifteen to twenty countries annually and makes recommendations on how countries can better protect, realise and embed children's rights in policy and practice. These recommendations are incorporated into domain 5 of the KidsRights Index.

The KidsRights Index is an initiative of the KidsRights Foundation, in collaboration with Erasmus University Rotterdam, the Erasmus School of Economics and the International Institute of Social Studies. In 2025, the KidsRights Index was published for the 13th time. This year, 194 countries are included.

STATE OF YOUTH



In addition to global awareness-raising and advocacy through the International Children's Peace Prize and the KidsRights Index, we believe that lasting change comes from below. The UNCRC emphasises not only the right of children to protection and development, but also their right to be heard and actively participate in decisions that affect their lives.

Based on that conviction, we developed State of Youth: a global youth movement in which young changemakers work together on social change within their communities. With State of Youth, KidsRights invests not only in participation, but above all in leadership, ownership and the power of young people to set change in motion themselves..

State of Youth International

State of Youth is the international changemaking community of KidsRights. Since the launch in 2019 at the World Summit of Nobel Peace Laureates in Mexico and the UN General Assembly in New York, State of Youth has grown into a global network in which young people themselves organise social change.

Young people between the ages of 12 and 29 start local Chapters, committing themselves to themes that directly affect their lives and future, ranging from climate and education to mental health, gender equality and children's rights.

The strength of State of Youth lies in ownership: young people determine the agenda themselves.

Of all Chapter activities, 90 percent now take place in rural and disadvantaged areas. Between 2019 and 2025, State of Youth grew into a network of more than 700 Chapters in over 70 countries.

PART 2: KIDSRIGHTS UK

Structure, Governance and Management

KidsRights UK is a registered charity (Charity Number 1213017), established in 2025 as the United Kingdom affiliate of Stichting KidsRights in the Netherlands. Registered office: 167-169 Great Portland Street, 5th Floor, London, W1W 5PF.

The charity is governed by a Board of Trustees, responsible for the strategic direction, governance and oversight of the organisation. The Trustees during the period were Marc Dullaert (Chair), Sandip Shah (Treasurer), Karolina Joynathsing and Jade Raad.

Day-to-day operations are led by the Country Director, Monique Surridge, who was appointed in September 2025.

As this was the charity's initial period of operation, the focus was on establishing appropriate governance structures, financial controls and compliance systems in line with UK regulatory requirements. Key administrative functions, including banking, financial reporting processes and charity governance procedures, were put in place during the period.

Objectives and Activities

The object of the charity is to promote and protect the rights of children and young people, in accordance with the principles set out in the United Nations Convention on the Rights of the Child.

KidsRights believes that children are not only vulnerable individuals who require protection, but also powerful changemakers capable of contributing to positive societal change.

To deliver its mission, KidsRights works across three interconnected pillars:

- **Advocacy** – raising awareness of children's rights globally, including through the International Children's Peace Prize
- **Research** – generating evidence-based insights through initiatives such as the KidsRights Index
- **Action** – empowering children and young people to drive change through programmes such as State of Youth

The Trustees confirm that they have had due regard to the Charity Commission's public benefit guidance when planning and carrying out the charity's activities.

During the period under review, activities focused on establishing the UK entity and contributing, where appropriate, to the international work of KidsRights.



Achievements and Performance

This reporting period covers the charity's first phase of operation, from mid September to December 2025. In advance of UK programme delivery, a number of important foundations were established

Key achievements during the period included:

- **Establishment of KidsRights UK.** The UK office was formally established as part of KidsRights' international expansion, strengthening its presence and enabling engagement with stakeholders in the United Kingdom.
- **Contribution to the International Children's Peace Prize (ICPP).** During the period, KidsRights UK supported the international promotion of the International Children's Peace Prize by engaging contacts and networks in the UK. This included raising awareness of the Prize among potential partners, supporters and relevant stakeholders, contributing to the visibility and reach of the initiative.
- **Early stakeholder and partnership engagement.** Initial outreach was undertaken to organisations within the UK children's rights, youth and education sectors to explore opportunities for collaboration. These early conversations focused on building relationships that will support future programme delivery and impact.

- **Fundraising and positioning groundwork.** The charity initiated early discussions with prospective donors and partners to establish future funding opportunities. Work also began on positioning KidsRights within the UK landscape as a credible and distinctive children's rights organisation.
- **Operational set-up and capacity building.** The recruitment of the Chief Executive Officer and establishment of basic operational systems enabled the charity to begin functioning effectively and to prepare for growth in 2026.

Given the short reporting period, the Trustees recognise that measurable impact in the UK is limited at this stage. However, the activities undertaken represent important early steps in building a sustainable organisation capable of delivering public benefit in future periods.

Statement of Trustees' Responsibilities

The trustees are responsible for preparing the Trustees' Annual Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (UK GAAP). The trustees are required to prepare financial statements which give a true and fair view of the state of affairs of the charity and of its incoming resources and application of resources for that period.

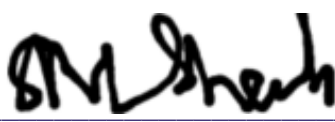
