Objectives and activities

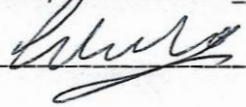

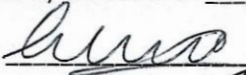

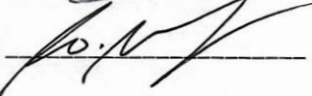
