**Objects:** THE OBJECTS OF THE CIO ARE, FOR THE PUBLIC BENEFIT:(A) THE ADVANCEMENT OF HEALTH AND THE PREVENTION OR RELIEF OF SICKNESS, DISEASE OR HUMAN SUFFERING (IN PARTICULAR BUT NOT LIMITED TO THE PROVISION OF MEDICAL EQUIPMENT, SUPPORT FOR EMERGENCY SERVICES AND THE PROMOTION OF MEDICAL RESEARCH AND THE PUBLICATION OF THE RESULTS OF SUCH RESEARCH);(B) THE RELIEF OF THOSE IN NEED BY REASON OF THEIR YOUTH, AGE, ILL-HEALTH, DISABILITY, FINANCIAL HARDSHIP OR OTHER DISADVANTAGE (INCLUDING BUT NOT LIMITED TO THOSE WHO HAVE BEEN EXPOSED TO WAR, POVERTY OR DISASTER) WITH THE OBJECT OF IMPROVING THEIR CONDITIONS OF LIFE;(C) THE ADVANCEMENT OF EDUCATION (IN PARTICULAR BUT NOT LIMITED TO THE DEVELOPMENT OF VOCATIONAL AND/OR NON-VOCATIONAL CAPABILITIES, COMPETENCES, SKILLS AND UNDERSTANDING THROUGH TRAINING AND MENTORSHIP PROGRAMMES AND PROMOTING THE ACCESSIBILITY OF EDUCATION);(D) THE PROMOTION OF THE CONSERVATION, PROTECTION AND IMPROVEMENT OF THE PHYSICAL AND NATURAL ENVIRONMENT (IN PARTICULAR PRESERVING THE CLIMATE, FLORA AND FAUNA IN ISRAEL);(E) THE PROMOTION OF EDUCATION REGARDING JEWISH AND ISRAELI HERITAGE AND CULTURE AND THE PROMOTION OF RELIGIOUS HARMONY THROUGH RAISING AWARENESS AND UNDERSTANDING OF JEWISH BELIEFS AND PRACTICES;(F) THE ADVANCEMENT OF THE ARTS, CULTURE AND/OR HERITAGE, IN PARTICULAR BUT NOT EXCLUSIVELY BY SUPPORTING THE DEVELOPMENT OF ARTISTIC CONTENT (I.E. CONCERTS, THEATRE SHOWS AND EXHIBITIONS) WHICH IS OF ARTISTIC MERIT AND FOR THE PUBLIC BENEFIT; AND(G) THE PROMOTION OF SUCH OTHER PURPOSES BEING EXCLUSIVELY CHARITABLE ACCORDING TO THE LAW OF ENGLAND AND WALES AS THE TRUSTEES MAY FROM TIME TO TIME DETERMINE IN PARTICULAR, BUT NOT EXCLUSIVELY, BY PROVIDING GRANTS, ITEMS AND SERVICES DIRECTLY TO THOSE IN NEED AND/OR TO CHARITIES OR OTHER ORGANISATIONS WORKING TO ADVANCE ANY ONE OR MORE OF THE CAUSES SET OUT AT SUBCLAUSES (A) TO (G).
