**Objects:** THE CHARITY'S OBJECTS ('OBJECTS') ARE SPECIFICALLY RESTRICTED TO THE FOLLOWING FOR THE PUBLIC BENEFIT:(1) TO ADVANCE EDUCATION IN MUSIC IN A WIDE RANGE OF GENRES, INCLUDING BUT NOT LIMITED TO CLASSICAL, JAZZ, OPERA, EARLY MUSIC, WORLD MUSIC AND ROCK AND POP BY PROMOTING MUSICAL KNOWLEDGE, SKILLS, AND UNDERSTANDING, PROVIDING MUSICAL TRAINING IN THE FORM OF MUSIC LESSONS, WORKSHOPS, AND PROGRAMMES AND BY SUPPORTING MUSIC PERFORMANCE BY PROVIDING OPPORTUNITIES FOR MUSICIANS TO PERFORM AT CONCERTS, RECITALS, OUTREACH PROGRAMMES AND OTHER PUBLIC EVENTS;(2) TO ADVANCE PUBLIC APPRECIATION OF THE ART OF MUSIC BY ENABLING THE PUBLIC TO ENGAGE WITH MUSIC THROUGH CONCERTS, RECITALS, OUTREACH PROGRAMMES AND OTHER PUBLIC EVENTS;(3) TO RELIEVE THE NEEDS OF PEOPLE WHO ARE SICK, CONVALESCENT, DISABLED OR INFIRM BY PROVIDING COMFORTS IN THE FORM OF OUTREACH MUSICAL ENTERTAINMENT;(4) TO ADVANCE IN LIFE AND RELIEVE THE NEEDS OF YOUNG PEOPLE BY PROVIDING SUPPORT AND ACTIVITIES WHICH DEVELOP THEIR SKILLS, CAPACITIES AND CAPABILITIES TO ENABLE THEM TO PARTICIPATE IN SOCIETY AS MATURE AND RESPONSIBLE INDIVIDUALS; AND(5) TO PROMOTE CHINESE, ASIAN, LATIN, AND EUROPEAN CULTURE THROUGH MUSIC, SONG, DANCE, FOOD AND PERFORMANCES. [NOTHING IN THE ARTICLES SHALL AUTHORISE AN APPLICATION OF THE PROPERTY OF THE CHARITY FOR PURPOSES WHICH ARE NOT CHARITABLE IN ACCORDANCE WITH SECTION 7 OF THE CHARITIES AND TRUSTEE INVESTMENT (SCOTLAND) ACT 2005 AND/OR SECTION 2 OF THE CHARITIES ACT (NORTHERN IRELAND) 2008.]
