(II)HOLDING MEETINGS FOR WORSHIP AND RELIGIOUS STUDY. (III)PROVIDING OPPORTUNITIES FOR SPIRITUAL GROWTH AND EXPLORATION THROUGH BIBLE STUDIES, FELLOWSHIP GROUPS, AND ACCESS TO FAITH BASED RESOURCES IN A SAFE AND WELCOMING ENVIRONMENT.
