FOR THE PURPOSE OF THIS CLAUSE 'SOCIALLY EXCLUDED' MEANS BEING EXCLUDED FROM SOCIETY, OR PARTS OF SOCIETY, AS A RESULT OF ONE OF MORE OF THE FOLLOWING FACTORS: UNEMPLOYMENT; FINANCIAL HARDSHIP; SOCIAL ISOLATION, BEREAVEMENT, OLD AGE OR ILL HEALTH (PHYSICAL OR MENTAL).

**Activities:** The organisation provides a safe, friendly space for its members that facilitates social contact (share stories and a cuppa), mutual support as well as providing the opportunity to take part in a range of activities, learn new skills and pass on skills to others. The shed is a place where skills are shared and friendships are built.
