Activities: Deaf Aspirations through its activities is reducing mental health and increasing well-being ;improving access in digital technologies and social media; including deaf people with some additional needs ; educating through leadership by motivation and mentoring via BSL/relevant communications ; teaching awareness of work skills-;creating deaf aspirational leaders through its successful projects.
